



## **Terms and Conditions**

*EFFECTIVE DATE: June 8, 2018*

The following Terms and Conditions shall apply to you all attendees (hereinafter, the "Visitor") who request admission to VAPEVENT MIAMI, held 8 - 9 November 2018 at the Soho Studios, Miami.

L&O EVENEMENTS is the Organizer (hereinafter, the "Organizer") of the event VAPEVENT MIAMI (hereinafter, the "Event"), international vape trade show.

The following Terms are subject to change without notice, and may be revised or updated from time to time in the Organizer's sole discretion. All amended terms shall automatically be effective immediately when posted on this website, and apply to all access to the Event and use of any websites, apps, or services in relation to the Event thereafter. The Visitor accepts that he is responsible for periodically returning to this website and reviewing these Terms to understand the current Terms and Conditions applicable to this Event. The Organizer does not and will not assume any obligation to notify the Visitor of changes to the Terms. The Visitor's continued use of any websites, apps, or services, or attendance at the event, means that he accepts and agrees to the changes.

Through his badge request, the Visitor accepts these Terms and Conditions as the exclusive and binding basis of contract.

### **ADMISSION POLICY**

The Event is open to trade professionals, vape professionals' association members and media only. No person under the age of 18 years, including children of exhibitors, will be admitted onto the show floor. Animals shall not be permitted to the show except for guide and assistance dogs.

All persons attending the Event should carry and produce on request a supporting personal photographic identity document (passport, photo-ID driving license, national identity document or similar) and a document proving their affiliation with the company name appearing on their registration (pay stub, business card, etc...). The Organizer reserves the right at its sole discretion to determine if a buyer is qualified to attend the expo based on the info provided. He holds the right to refuse entrance/service to anyone.

No person named on the badge or the company, firm or business, which that person represents, may permit the badge to be worn by another person. The wearing of a badge under these circumstances will constitute appropriation, an automatic termination of such license and will be sufficient grounds for the unauthorized individual to be removed from the exhibition. Identity checks will be conducted as a condition of entry. Any person found to be registering to attend the Event using false

information or credentials or deliberately with-holding information will have their application automatically denied.

Any visitor certifies and agrees that entering in the main room of the exhibition will expose them to vapor from e-cigarette use. The Organizer will not be held liable for any trouble regarding vape products exposure.

## GENERAL RULES

The Visitor consents to be photographed, filmed and/or recorded for broadcast, marketing, show promotion or security purposes during the event. The Visitor also consents to them being used for other marketing and publicity related purposes.

The distribution of leaflets or any other advertising material or the sale of articles anywhere within the show premises is strictly forbidden. The Organizer reserves the right at its absolute discretion to confiscate such articles for infringement of this condition. Ambush marketing is strictly prohibited and anyone caught carrying out such an activity will be evicted from the show and potentially be subject to prosecution. You must not breach or infringe the rights of any sponsors, suppliers, broadcasters, exhibitors or other parties commercially associated to the show.

There is no smoking allowed inside the Soho Studios. Alcohol shall not be consumed within the show premises. Illegal substances will not be tolerated and the Organizer reserves the right to remove any visitor from the show if he believes that they are either carrying or using any illegal substances.

All damage to property, accidents and injuries incurred at the event must be reported to the Organizer or security agent immediately in accordance with show health and safety procedures.

The Organizer reserves the right at all times to refuse or restrict the use of any facilities and to eject without prejudice any person refusing to comply with these Conditions, or who the Organizer reasonably believes to behave inappropriately in any way, cause damage or annoyance to any other persons or property.

## PRIVACY POLICY

The information collected (e.g. name, e-mail address, postal address, phone numbers and other contact information) when requesting a badge is for event registration, event management, marketing and promotional purposes and may be shared with other organizations with a similar purpose to Organizer's. The Visitor agrees that the Organizer may use and share such information from time to time.

## CANCELLATION

The Organizer reserves the right to defer, rearrange, amend or cancel the event at any time. In the event of cancellation or postponement, the Organizer will not be held liable for any personal costs that the Visitor may have incurred i.e.: travel or accommodation costs...

## LIMITATION OF LIABILITY

By having a badge, the Visitor shall indemnify and hold harmless, The Organizer, The Soho Studios and/or their board of directors, partners, officers, agents and employees from any claims, liability, damage, health issues, expenses, actions and judgments recovered from the Vapevent being held on November 8<sup>th</sup> and 9<sup>th</sup> of 2018.

Furthermore, the above is not liable for:

- Any damage to property, accidents or injuries incurred at the event, health concerns or death of any persons on or off site before, during or after the event.
- Side effects and addictions associated with vaping paraphernalia and nicotine usage.

## WARNING

Visitors understand that during the event they will be exposed to an environment where a large amount of vaping will be occurring. Some if not all the vaping happening during the event could contain nicotine. Nicotine is and habit forming and it can be very toxic by inhalation, in contact with the skin or swallowed. Nicotine can increase your heart rate and blood pressure and can cause dizziness, nausea and stomach pain. Inhalation of any product may aggravate existing repertory conditions. By ingestion, nicotine can be poisonous. Visitors accept these and all other risk and liabilities associated with e-cigarettes and the products in the Vapevent floor.

Visitors are hereby warned of the dangers of nicotine and promise to responsibly follow safe practices. Therefore, visitors understand that:

- Misuse or overdose of a nicotine product is solely the responsibility of the attending visitor and will in no-way hold accountable the Organizer, other members, attending vendors or its affiliates accountable.
- Nicotine is addictive and habit forming.
- Nicotine can be harmful and should always be kept away from all children and pets.
- Nicotine should never be used by pregnant women or nursing mothers.

## GOVERNING LAW

These Terms shall be governed and construed in accordance with the laws of the State of Florida without giving effect to conflicts of law principles.
